1. Promoter

This Trade Promotion is conducted by BJJ Escapes Pty Ltd ABN 95 343 704 010, referred to herein as "the Promoter". The promotion is operated in accordance with Australian law. The draw will be held in Australia.

2. Promotion Overview

This promotion is a game of chance conducted to promote BJJ Escapes events. The prize is a Private Room Ticket to the Kingcliff BJJ Escapes Event (3–6 July 2025). The prize includes luxury accommodation and full camp access, valued at AUD \$2,440. This promotion is in no way sponsored, endorsed, administered by, or associated with Facebook, Instagram, or any other third-party platform used for promotion.

3. Eligibility

- Entry is open to Australian residents aged 18 years or over.

- Directors, officers, employees, contractors, and their immediate families of the Promoter and associated entities are ineligible to enter.

- Entrants may purchase multiple tickets to increase their chances of winning.

- Each ticket equals one entry.
- Tickets are non-refundable and cannot be exchanged for cash or credit.

- Upon successful purchase, entrants will receive a confirmation email. Ticket numbers will be randomly assigned and recorded by the Promoter.

5. Draw Details

- The draw will take place on Tuesday 30 April 2025 at 12:00pm AEST.

- The draw will be conducted via a digital random wheel generator and independently scrutinised.

- The first valid entry drawn will win the prize.

- The draw process and entries will be documented for audit purposes and to ensure fairness.
